
1. On February 8<sup>th</sup> 2009, the Defense and the Assistant State Attorney's assigned to this matter met and where able to agree on a overwhelming majority of all discovery issues.
2. The Defense stipulates to the State of Florida's proposed motion with one significant exception.
3. The Defense respectfully requests that this Honorable Court exclude the Oak Ridge Laboratories and it's agents from the forensic science expert witness deadlines or in the alternative set a later date for this agency.
4. The Defense's basis for this request is that it has been brought to the attention of the Defense and the State of Florida that the Oak Ridge

Laboratory may attempt to claim that this Honorable Court does not have jurisdiction over them, as such a considerable amount of litigation may ensue to resolve this issue.


