MOTION TO WITHDRAW AS COUNSEL

COMES NOW ANDREA D. LYON, and respectfully asks this Court for leave to withdraw as counsel for Casey Marie Anthony.

In support of this Motion Ms. Lyon states as follows upon information and belief:

- 1. In June of 2009 the undersigned was admitted pro hac vice as death-qualified counsel on behalf of Casey Anthony after the State had reversed its position and decided to seek the death penalty.
- 2. On March 18, 2010, Miss Anthony presented her Motion to Declare Indigency for Costs. At that hearing, the undersigned indicated that she was and had been appearing on a pro bono basis, but that the funds she had received for costs were not even a third of what it had cost for the first ten months of representation.
- 3. Judge Strickland granted that motion, declaring Miss Anthony indigent for costs and indicating that Miss Anthony and her team must abide by the Justice Administration Commission (JAC) Rules.

- 4. On May 12, 2010 this Court entered an order nunc pro tune to May 6, 2010 granting certain funding requests and denying others. Among the requests that were denied, travel expenses for defense counsel were denied. It is the undersigned's understanding the JAC does prohibits payments of such costs.]
- 5. Undersigned counsel cannot continue to represent Miss Anthony in the absence of quite substantial funds to cover the costs, which she anticipates will increase as trial approaches.
- 6. Undersigned counsel has worked many hundreds of hours on this case, believes in her client and her client's cause, and does not wish personally or professionally to withdraw from this case. Nonetheless, for the reasons stated above, she has no choice.
- Undersigned counsel will of course cooperate fully with the excellent team with which she has had the honor to associate with thus far.
