Dear Ms. Anthony,

Hello. Hi. My name is Ryan Nixon. I am writing mainly out of curiosity. I know you probably get a lot of mail, and I do not anticipate a return letter; however I would appreciate one.

I am 28, a former enlisted man in the Navy who detests what the military does. I am a student of Political Science at Old Dominion University in Norfolk, VA. I plan to go to school at the American University of Beirut in Lebanon after I graduate. My girlfriend is also Lebanese, but I am just a white guy.

A little more about me and what led me to sympathize with your case (Note I will never ask you any questions about your case, and I hope you will not tell me anything I can't see on the news myself):

On October 17, 2005 my sister, Christy Anne Nixon, was murdered by a drug dealer who ~~was~~ went by Ben Lau, but no one knows his real name. He disappeared before the police could arrest him. After this happened I went to the media to protest against the death penalty in Virginia, the U.S., and worldwide. I recieved a lot of attention, and I even testified about capital punishment not helping victims' families before Congress.

And then on September 9, 2009, I was falsely arrested for rape after an ex-girlfriend lied to police about our relationship because I broke up with her. She first said it happened in Hampton, VA in June 2009. Hampton

it happened at a party and that she had many witnesses. After the police questioned those witnesses, they admitted that it never happened.

She then told Norfolk police that I raped her at my house in Norfolk. She said it happened in June. I was able to prove that I was in New Orleans during the first three weeks in June and that she was in Tennessee during the last week. We were never in Virginia at the same time in June.

After that she changed her charge to April, 2009. When she was cross examined she couldn't answer any questions. She kept saying "I can't remember." Finally we asked if she remembered being raped. She said no. She said she wasn't drunk or on drugs. She said she knew I raped her because I bragged to her that I had. I never said any such thing. Finally she confessed that I never raped her. She said the reason why she did it ~~was~~ was because she thought I loved her.

Because of everything I've been through, I have ~~a lot~~ deep compassion for prisoners and people facing trial. I even ~~decided~~ chose to write this letter by hand because I remember being in jail facing a rape charge and it always felt cold to get a typed letter.

I sincerely hope for and wish you the best of luck in your upcoming trial. I know you've been through a lot in the last few years. I can't imagine it, but I know a little how you're feeling.

I also want you to know that there are a lot of us out there who don't pay any attention to the things the media says

about you. I know you're not a monster. Even if you did this crime, I believe you're a beautiful young woman who made a mistake. But I don't believe you did it. It's not up to me, as a human being, to condemn anyone. The only person who knows is you. And I will always have more than reasonable doubt in your case.

I hope you're doing well in jail. I remember how boring, lonely, and hard it was in jail. I hope you're getting everything you need. I'm sure you have enough in your canteen account, but I'd gladly send you a few bucks if you ever needed it. Also I remember how much I yearned for a decent book to read when I was in jail. I could send you some.

Anyway, I know things are hard for you right now. Try to stay positive if you can. I'll write back if I hear from you.

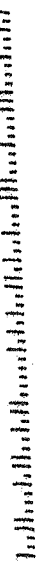

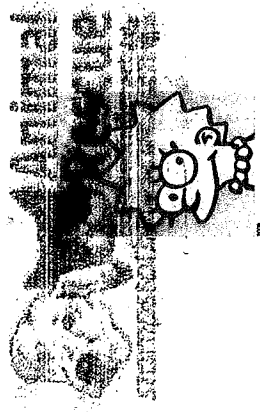

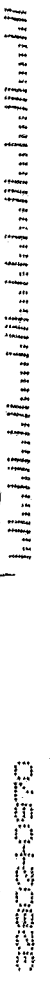

So, I am sitting here on a Saturday night, bored, as I am sure you are sitting bored down there, so I guess we have something in common. I might put a movie in later, don't know. I have "Halloween" one of my all time favorites. Do you like slasher flicks?..I should not, but have to admit they are a guilty pleasure. I bet you had better taste. I don't know, if I watch that, I might want a beer..so who the hell knows, right?

My comp sucks..well, my internet is really slow, don't know if it's my computer or not. At least I have it, so I guess I should not complain, but it sucks, being this slow.


Like you care, I know...but hey, I am sure you remember how annoying it can be.

The Messiah's rule will bring earthly benefits beyond compare, accomplishing everything good that God originally purposed for his people to enjoy on earth. Hatreds and prejudices will cease to exist, and eventually everyone on earth will be a true friend of everyone else. In the Scriptures, God promises that he will "make wars to cease to the extremity of the earth." "Nation will not lift up sword against nation, neither will they learn war anymore."—Psalm 46:9; Isaiah 2:4.

The whole earth will eventually be brought to a gardenlike paradise state. The Scriptures say: "The wilderness and the waterless region will exult, and the desert plain will be joyful and blossom as the saffron. . . . For in the wilderness waters will have burst out, and torrents in the desert plain. And the heat-parched ground will have become as a reedy pool, and the thirsty ground as springs of water."—Isaiah 35:1, 6, 7.

There will be every reason to be happy in the Paradise earth. Never again will people feel hunger because of lack of food. "The earth itself will certainly give its produce," the Scriptures say. (Psalm 67:6; 72:16) All will

enjoy the fruits of their own labor, as our Creator promises: "They will certainly plant vineyards and eat their fruitage. . . . They will not plant and someone else do the eating."—Isaiah 65:21, 22.

In God's new world, no longer will people be crammed into huge apartment buildings or run-down slums, for God has purposed: "They will certainly build houses and have occupancy. . . . They will not build and someone else have occupancy." The Scriptures also promise: "They will not toil for nothing."—Isaiah 65:21-23.

In time, God's Kingdom will even restore the peaceful relations that existed in the garden of Eden between animals, and between animals and humans. The Scriptures say: "The wolf will actually reside for a while with the male lamb, and with the kid the leopard itself will lie down, and the calf and the maned young lion and the well-fed animal all together; and a mere little boy will be leader over them."—Isaiah 11:6-9; Hosea 2:18.
